

MEMORANDUM FOR ARMY NAF HUMAN RESOURCE OFFICES

SUBJECT: Selective Service Registration Requirements for Nonappropriated Fund (NAF) Positions

1. Reference Department of Defense Instruction (DoDI) 1400.25-V1403, 20 March 2015.
2. The reference extends the Selective Service Registration requirements of section 5 USC 3328(a) to individuals selected for DoD NAF positions. This is to advise you of this requirement and its application to all individuals selected for Army NAF positions.
3. All vacancy announcements must include the following statement concerning Selective Service Registration: "Any individual who was required to register with Selective Service and who is not registered or knowingly and willfully did not register before the requirement terminated or became inapplicable to the individual, will not be appointed."
